

## Mexican Riviera Cruise Review

### Friday, Sept. 25

As everyone from the Reunion scattered towards their many destinations, Ben put Tom and George Hughes in charge of making sure all the cruise people caught the right shuttles from the hotel to the port. Hmm ... this could have been trouble, but all worked well and everyone made it to the ship in plenty of time. After checking out our cabins and the gorgeous Radiance of the Seas, it was already dinner time. Dinners are always fun on cruises, and these dinners were no exception. You want two appetizers? Sure! You prefer a soup for the main course?? Of course! Two desserts? No problem. We had beautiful tables with fantastic views, the food was all delicious and the wait staff was very attentive.



### Saturday, Sept. 26

Our first port of call was Ensenada. Some selected one of the ship's tours, which were inexpensive; others trekked out on their own. A couple of the tours were canceled because of concerns that the big bike race scheduled would delay arrival times back at the ship.

Mike and Linda headed to her favorite jeweler and bought a special new piece for her collection. Tom and I chose to see La Bufadora, a spectacular natural blow hole about an hour out of town. The closest translation of La Bufadora is "The Snort." The area between the port and La Bufadora was industrial and poor. The guide asked us what we saw that was like in America. Most answers were the obvious: McDonalds, KFC, Burger King, NO Taco Bell, Costco, Home Depot, etc. The guide said that one previous tourist had noted that there were also a lot of Mexicans!



Upon arrival at La Bufadora, our driver parked on a primitive clay field. We had to then maneuver through a long alley lined with tent-style shops and hawkers urging you to step into their "non-profit" store. Whew! Visions of The Sook in Tunis continued to appear in our heads. Guess that is the selling style in any depressed area of the world. We escaped buying anything on the way to La Bufadora, but did stop at one shop later where I bought two pair of earrings that started out priced at \$185 and ended up at \$40. All I had to do was keep walking out of the shop and apologizing to the guy that I just did not want the earrings!

When we got back on the ship and saw coupons being given out on the ship for a 10% discount at selected stores, we were tickled! If someone could not get at least 10% off in Mexico, they might as well wait and just buy whatever it is back in the good ole' USA – or they deserve to pay too much! We did enjoy buying a little bracelet for the granddaughter, Amelia, with her name on it and watched them make it. The cost was three dollars!

One group of five people (NOT in our group!) decided to go golfing on their own (without a ship-sponsored tour), allegedly to save a few bucks. Apparently, they did not fully appreciate the impact that the scheduled bike race would have on traffic patterns when returning to the ship, and they did not make it back in time. The captain made several announcements about the reasons for our delay and actu-



ally waited about twenty minutes beyond scheduled departure time. He finally announced we could wait no further since we had our next port of call to meet, and off we sailed. We heard later that the missing passengers had to go back to San Diego and forfeited the rest of the cruise as well as a lot of money!

### Sunday, Sept. 27

Sunday was a day at sea. I have decided that sea days are pretty darn cool. To make it even better, Tom's and my cell phones weren't working well at all – an experience we don't get too often and a reminder of the "olden days" without constant and immediate communication. This is not to say, however, that it was cheaper (!) to be at sea. The spa helped take care of that! Tom and I both enjoyed the spa, but if you really want a GREAT spa story, ask Ben and Lynn about their experience in Budapest. I have not laughed so hard in years!! ### Monday & Tuesday, Sept. 28 & 29

The port of Cabo San Lucas was quite beautiful on approach. The town itself is more of an upscale resort than Ensenada and very Americanized (nearby San Jose del Cabo gets the nod for being more quaint and historic). Most of the town's attractions are located very near the port, and we could see some of the beaches and the famous Arches as we entered the

The tour provided water, beer and margaritas, and we probably drank our ticket price in water! I think it was 96 degrees with about 115% humidity (sure, that IS possible!).

We heard that several of our group went snorkeling. That included Bill & Dee Davis and Ben & Lynn. George Hughes was on the boat with them, but he was on the snuba adventure, with his own mini-sub. George was a kid all over again! Other Avianoites tried various activities and fun was had by all.

We returned to Cabo and walked through the flea market, but the severe heat burned us out and headed straight to lunch, thereby beginning another day and a half on the ship! (Elaine LIKES THIS, as they say on Facebook!) That evening, some of us tried out the Italian specialty restaurant, Portofino. The food was quite good, but those who were in the dining room dined on lobster tails, so I guess it is debatable as to who got the better end of that deal! It was nice to have a smaller setting to get to visit with our dinner partners.

After another beautiful day at sea (and cooler temperatures), we reluctantly packed up for our departure the next morning. The final dinner was fun, the waiters sang, and the entertainment after dinner was funny. It was a beautifully relaxing cruise!

### **Wednesday, September 30**

We disembarked that morning about 1 - hours late due to some type of customs problem. Tom and I, and Ben and Lynn met up with some Aviano friends who had not been able to attend the Reunion or the cruise, George and Nancy Beckwith. They met us at the port and walked with us to Seaport Village where we visited over some ice cream and laughed a LOT! It was like we were all 20-somethings again back in Aviano. They then drove us to the airport. It was a perfect end to a lovely trip.

### **One more note from Lynn**

I must say that I love Radiance class ships--Jewel, Serenade, Brilliance, and Radiance. Ben and I have sailed on over 50 cruises on ships as varied as the largest in the world, Oasis of the Seas, holding over 5000 passengers, to river cruise ships maxing at about 140 passengers. Radiance ships are just about the right size. Deck 6 features the Bombay Billiard Club with two self-leveling pool tables, the champagne bar, cinema, theater, two alternative restaurants (Portofino and Chops Grille), and some really cool bars--Singapore Sling's, Schooner Bar, Jakarta Lounge, and Scoreboard Sports Bar. From rich wood decor to the signature glass elevators overlooking the ocean, not to mention the 2500 passenger capacity, this class ship is one loved by passengers and crew alike.

Hotel Reservations should be made directly with the Hotel at 615-883-2211 and identify yourself as part of the Aviano Reunion or Group Code X-AVI-AN. Rates for the standard room will be \$175.38 inclusive of local taxes for double occupancy. Additional persons per room (up to 4) are charged \$20.00 per person plus tax. Children are free. A premium room with a balcony overlooking the atrium can be had for an additional \$35.00 plus tax. The standard resort fee has been waived for our group and includes high speed wireless internet, local and toll free calls up to 20 minutes, access to the fitness center, daily news-paper delivered to each room, two bottles of water refreshed daily and scheduled complex transportation. If driving, parking is available for \$18.00 per day. Reservations must be made no later than October 29, 2010 to obtain these rates.
